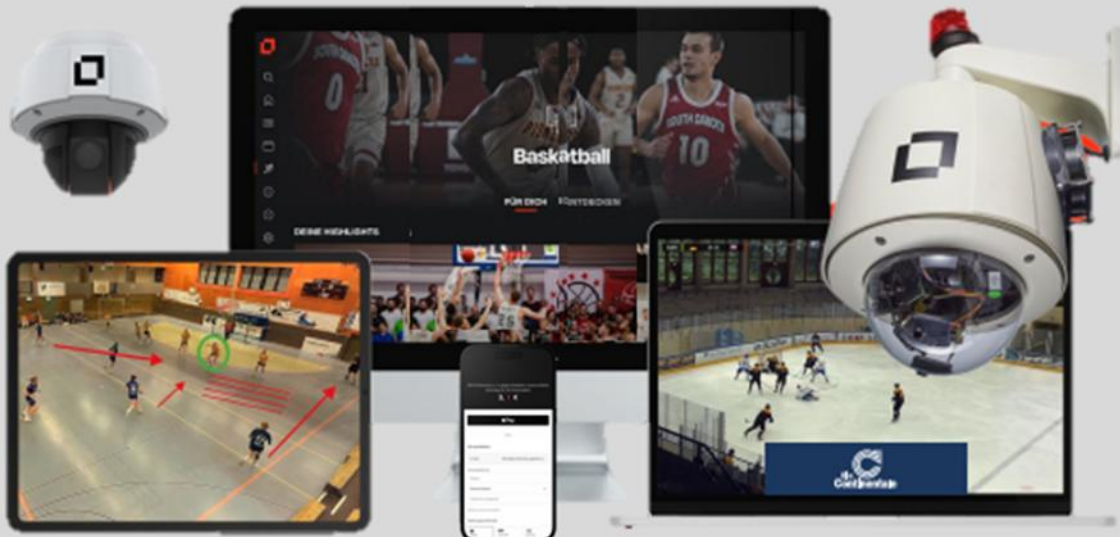

What's it all about?

Staige One AG's 2025 results highlight an operationally progressive but financially high-risk transition year. Revenue stagnated at EUR 2m, though cost cuts trimmed EBITDA losses to EUR -2.5m. The company's future investment thesis depends on its pivot from amateur sports streaming toward "Staige for Industries," utilizing its proprietary edge-AI and camera technology for logistics, security, and public-sector projects. While a EUR 20m pipeline and support from anchor shareholders like adesso SE stabilize the near-term profile, management's ambitious 2026 guidance—targeting EUR 4.1m in revenue and near-break-even EBITDA—demands swift commercial execution. Given the balanced mix of technical validation and high execution risks, we reiterate our Speculative BUY rating with an unchanged PT of EUR 2.50.

Final FY25 results in-line; Ambitious FY26 goals; Spec. BUY

Transition year with mixed outcomes. Staige One AG published its final FY25 results, framing the period as a major transition year. While the company achieved operational and strategic milestones, the financial results clearly lag behind the ongoing transformation story. Revenue remained flat at around EUR 2m, missing previous growth projections. On a positive note, cost-reduction measures successfully narrowed the EBITDA loss from EUR -3.5m to EUR -2.5m. However, net loss remained heavily depressed at EUR -4.2m, burdened in part by a EUR 1.0m extraordinary write-down of deferred taxes.

Strategic pivot to industrial analytics. In our view, the core strategic highlight is the structural shift away from the legacy sports-video technology toward “Staige for Industries”. The company is increasingly deploying its AI, camera, edge-computing, and computer-vision capabilities into larger, higher-margin non-sports sectors, including security, logistics, and public-sector video analytics. Management reports a robust pipeline of roughly 90 opportunities representing over EUR 20m in revenue potential. Early proof points are emerging via reference wins with adesso, Toll Collect, and a multi-year public-sector project worth approximately EUR 600k.

Execution and liquidity risks persist. While the industrial pivot is strategically encouraging, we believe the financial profile remains high-risk. The business is structurally loss-making, with an EBITDA deficit that still exceeds its annual revenue. Financial support from anchor shareholders adesso SE and Malo Industriebeteiligungen—including capital increases and loan extensions—provides necessary near-term liquidity stability, but underscores that Staige is not yet self-financing. For FY26, management guidance projects a sharp inflection: revenue doubling to EUR 4.1m (with over EUR 1.0m from industrial), near-break-even EBITDA, and positive operating cash flow in H2 2026.

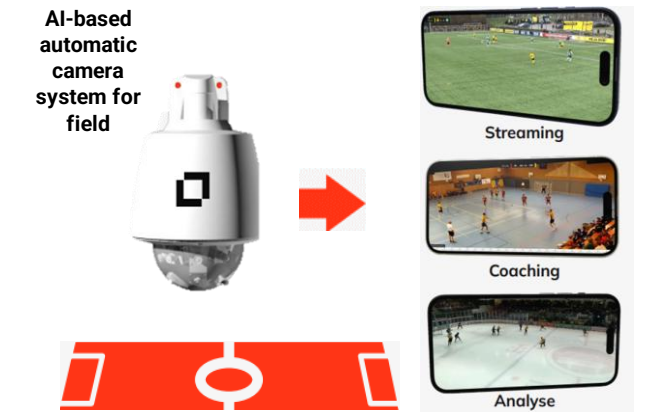
Company description

Staige One is a SaaS technology company providing an entire ecosystem in order to digitize (predominantly) amateur sports. The company's product offering ranges from an AI-based automatic camera, coaching and analytic tools, a streaming platform (staige.tv) as well as advertising capabilities. Staige targets eight sports but its main focus is on football in the DACH region.

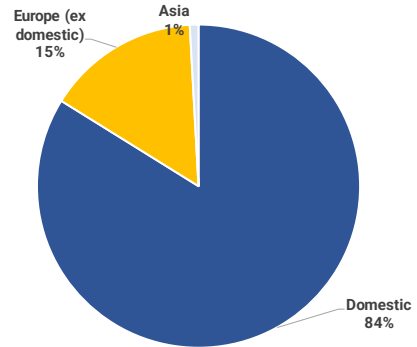
Conclusion. We believe the investment case now hinges entirely on converting the industrial pipeline into scalable, recurring revenue. The 2026 targets are ambitious and require strict validation against concrete contract wins and reduced cash burn. We maintain our Speculative BUY rating with an unchanged PT of EUR 2.50.

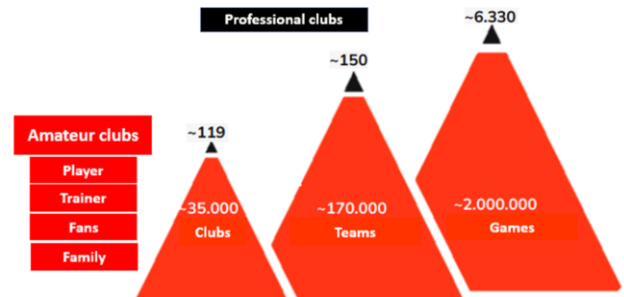
Regional sales split 2025 in %

SWOT analysis

Strengths

- Seasoned and skilled management team (both management and supervisory board)
- Proprietary technology and patents -> camera, streaming platform
- In-house developed and with own data continuously trained AI-tools
- Dominant market position in the DACH region
- Scalable and recurring business model
- Strong customer loyalty (less than 5% churn rate)
- Strong customer base with currently more than 1,200 clubs
- Diversified revenue streams (clubs, sponsors and end consumers)
- Strong partners (professional clubs such as Borussia Dortmund but also national Federations (DFB, DEB) and adesso on the development side)

Weaknesses

- Highly capital intensive in order to built up distribution network
- Competition from relatively larger players outside the DACH region
- Many competing streaming platforms
- High dependence on the German speaking market
- Relatively high start-up costs (camera)

Opportunities

- Digitizing amateur sports still is in its infancy (less than 1% penetration)
- Increased awareness through professional sports partners
- Large market potential in Germany and abroad
- Competitive advantages through covering the entire value chain (own camera, AI tools and streaming platform)
- As the club customer base grows, so does the regular recurring revenue base.
- More cameras sold should lead to higher upselling opportunities
- Favorable economies of scale and high margin potential from streaming and coaching
- Staige for Industries

Threats

- Competitors could offer cheaper products
- Large technology companies enter the market as competitors
- Clubs develop their own broadcasting systems
- Continued cost pressure on clubs, resulting in declining demand

FCF Yield Model

Due to the fact that companies rarely bear sufficient resemblance to peers in terms of geographical exposure, size or competitive strength and in order to adjust for the pitfalls of weak long-term visibility, an Adjusted Free Cash Flow analysis (Adjusted FCF) has been conducted.

The adjusted Free Cash Flow Yield results in a fair value between EUR -1.40 per share based on 2026E and EUR 2.42 per share on 2030E estimates.

The main driver of this model is the level of return available to a controlling investor, influenced by the cost of that investors' capital (opportunity costs) and the purchase price – in this case the enterprise value of the company. Here, the adjusted FCF yield is used as a proxy for the required return and is defined as EBITDA less minority interest, taxes and investments required to maintain existing assets (maintenance capex).

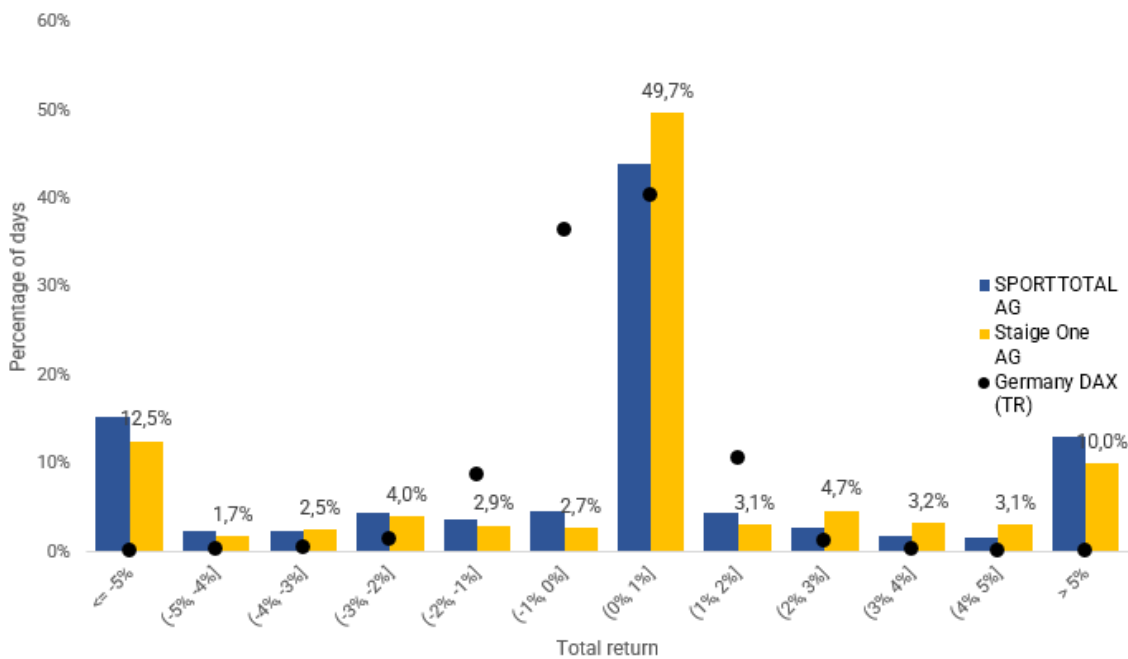

Simply put, the model assumes that investors require companies to generate a minimum return on the investor's purchase price. The required after-tax return equals the model's hurdle rate of 7.0%. Anything less suggests the stock is expensive; anything more suggests the stock is cheap. **ESG adjustments might be applicable. A high score indicates high awareness for environmental, social or governance issues and thus might lower the overall risk an investment in the company might carry. A low score on the contrary might increase the risk of an investment and might therefore trigger a higher required hurdle rate.**

Risk

The chart displays the **distribution of daily returns of Staige One AG** over the last 3 years, compared to the same distribution for SPORTTOTAL AG. We have also included the distribution for the index Germany DAX (TR). The distribution gives a better understanding of risk than measures like volatility, which assume that log returns are normally distributed. In reality, they are skewed (down moves are larger) and have fat tails (large moves occur more often than predicted). Also, volatility treats up and down moves the same, while investors are more worried about down moves. For Staige One AG, the worst day during the past 3 years was 08/05/2024 with a share price decline of -42.5%. The best day was 10/04/2024 when the share price increased by 58.5%.

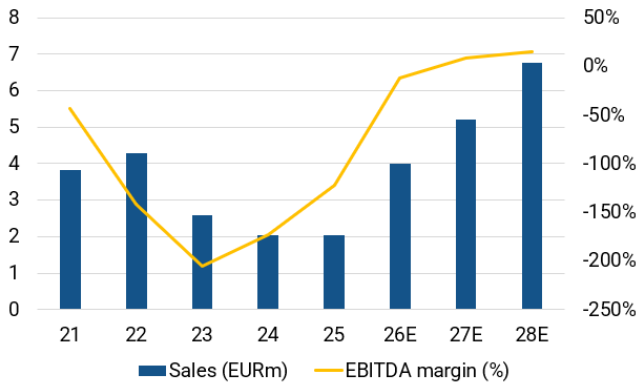
Risk – Daily Returns Distribution (trailing 3 years)



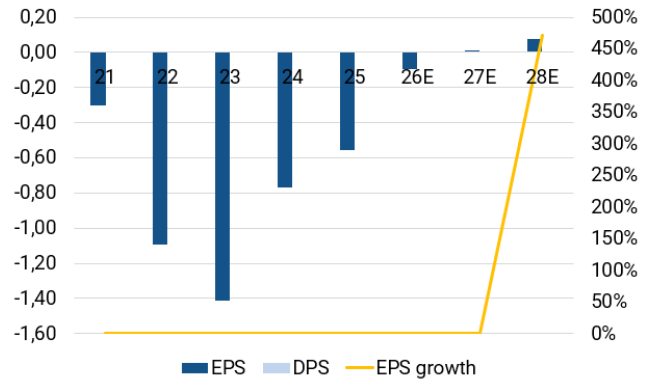

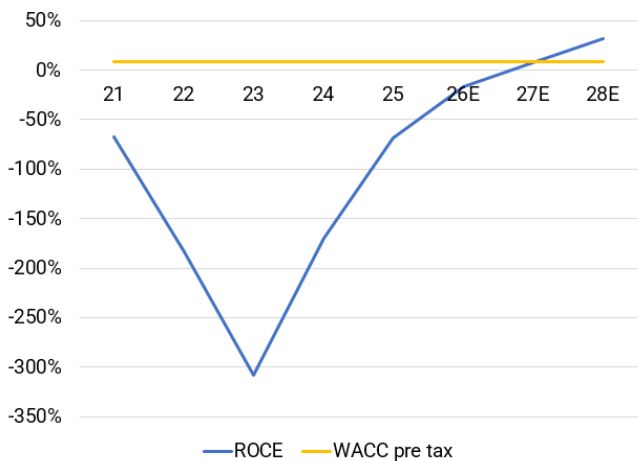
Sales vs. EBITDA margin development



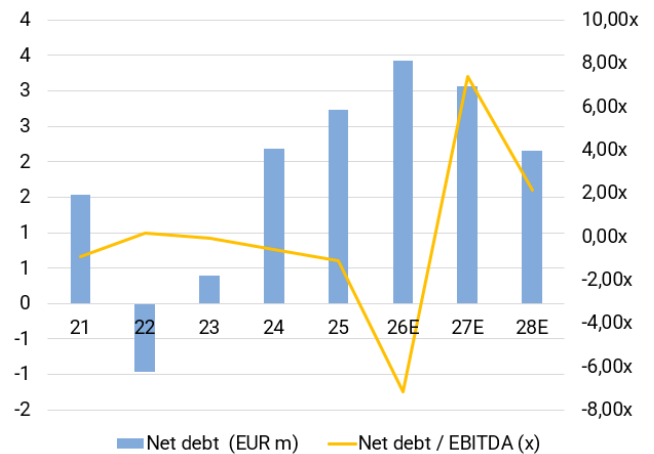
EPS, DPS in EUR & yoy EPS growth



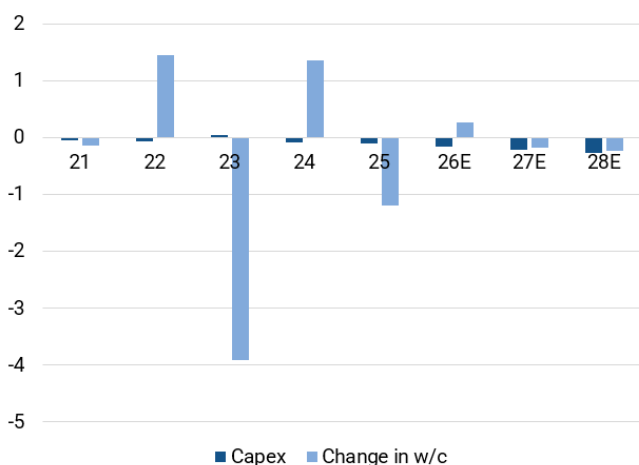
ROCE vs. WACC (pre tax)



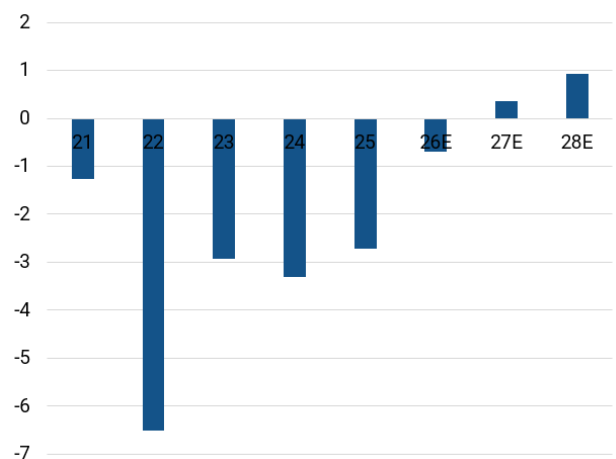
Net debt and net debt/EBITDA
